# **HOUSE RULES**

Amended July 2018

## INTRODUCTION

These Club “House Rules” have been prepared by the Club’s Directors under the mandate given to them by the members. They are in place for the primary purpose to enable all members, visitors and guests to enjoy our facilities in a friendly, social and safe environment.

The Management and Staff are responsible for ensuring these House Rules are adhered to and all members, visitors and guests must take responsibility to respect these rules at all times.

### 1. CLUB HOURS

Monday to Friday	9am to 5am
Saturday	9am to 3am
Sunday	10am to 11:30pm

Hours may change from time to time. Any alterations will be displayed on the Club's in-house monitors.

### 2. DRESS RULES

**General:** Neat, clean clothing at all times, appropriate to occasion. Baggage and clothing must not be deposited in the Club Foyer. Management has the right to arbitrate rules for Affiliated Club functions.

#### (a) Gaming Room

**Not acceptable at any time:** Bike shorts, ripped clothing, moccasins, T-shirts with offensive motifs, slippers, football gear, singlets, headwear, dirty footwear or clothing.

#### (b) Bistro

**Not acceptable at any time:** Bike shorts, ripped clothing, moccasins, T-shirts with offensive motifs, slippers, football gear, singlets, dirty footwear or clothing.

#### (c) Sports Bar

**Not acceptable at any time:** Dirty work boots or work clothing, slippers, football gear (jumpers, boots and socks) and singlets.

*Note:* Singlets may be worn into the Sports Bar when a member may call in to purchase alcohol to take away. The club recognises the need to allow access to members from all vocations, however, we would appreciate that persons engaged in dirty occupations carry a change of clothing or footwear for their club visit.

**(d) Blue & Gold Room**

Same dress rules as the Lounge / Bistro.

### **3. BEHAVIOUR**

Membership cards must be carried at all times or the member is required to enter their name and other particulars in the Visitors book. Failure to do so may incur a suspension. Spot checks may be carried out at random.

Persons leaving the Club premises late in the evening or early morning will be expected to leave in a manner, which does not unduly disturb neighbouring residents.

Members will behave in a proper manner without causing any inconvenience to other members and their guests. The term "behaviour" is to include: dress, language, actions and any annoyance which, in the opinion of Management, is detrimental to other members and the reputation of the Club. Members are solely responsible for their guests' behaviour.

Failure to comply with the proper behaviour will result in the member being asked to immediately leave the premises and may be suspended until such time the Disciplinary Committee has reviewed all reports pertaining to the member's behaviour.

Should a member be involved in a major disturbance, or action that has endangered, upset or harmed, other members, guests or staff member, the member will be immediately suspended from the Club until a Disciplinary Committee hearing is conducted to determine the incident.

The Disciplinary Committee's determination may result in a fine, suspension or cancellation of membership.

Disciplinary Committee hearings will normally take place as soon as practicable and usually within ten (10) working days of an incident.

## **4. VISITORS & GUESTS**

Every visitor/guest (“guest”), or group of guests, shall be accompanied by a member who shall enter the name and other particulars of his/her guest(s) in the Visitors books when entering the Club, no dittos are permitted (one month automatic suspension). The guest(s) may remain on the Club premises only while accompanied by the member who introduced such guest(s).

No member shall introduce more than four (4) guests to the club in any one day, and an individual will not be permitted to be guest on more than twelve (12) occasions in any year (this does not apply to special functions).

The behaviour of guests to the Club shall be the responsibility of the member who introduced the guest to the Club on that occasion.

A guest may be denied entry to the club by a Board of Directors decision, if that guest has acted contrary to the rules of the Club or behaved offensively in the Club premises.

## **5. CHILDREN**

Children and persons under the age of 18 years are permitted at the Club during the following times and must be accompanied by a parent or guardian at all times.

### **Bistro; Sports Bar; Blue & Gold; Bowls Club**

Monday to Saturday: 9am – 11pm

Sunday: 10am – 8pm

*Note:* - Children 12 years and under are not permitted in the Sports Bar after 7pm.

- Persons under the age of 18 years are not permitted in the Gaming Room at anytime.

Other than these times, persons under the age of 18 years may be admitted to the Club or permitted to stay longer when special permission has been granted by Management.

It is the sole responsibility of the member for the proper conduct of children in their care. If, in the opinion of Management, the behaviour is not satisfactory, the member and children will be asked to leave the premises immediately.

Children must be seated with parents or guardians at all times. They are not permitted to play or linger in the foyer or car park areas. Children can not be left unattended in a car at anytime.

Children under the age of eighteen (18) will not be served alcohol at the bar and are not permitted to be in the immediate vicinity of the TAB betting terminals.

When children are asked to leave the premises, they must not remain anywhere within the clubrooms, concrete areas, foyers, stairways or car parking areas of the Club.

Management reserves the right to declare certain functions or special band/theme nights as “adults only” should the need arise.

## **6. CAR PARKING**

There are, at the entrance to the Club, sign-posted and reserved parking bays for Directors, Management and Disabled to park their vehicles. These are not to be used at any time by members or their guests.

## **7. GENERAL**

The Club shall not be used as a regular business address or as an address in any advertisement by any member of the Club.

Any member or guest to the Club causing damage to any article or property of the Club may be called upon and bear the cost of replacement or repair of such article or property.

Any member who has a complaint to make against another member, employee of the Club or the conduct of the Club, shall lodge a complaint in writing to the Company Secretary.

The playing of cards will be allowed in the Club premises provided that no betting is introduced.

The Management shall have the right to ask the members to make prior bookings for functions being conducted at the Club. Members who fail to make appropriate bookings may be unable to participate in a particular function.

Liquor shall not be sold or supplied to any person under the age of 18 years and members or guests shall not attempt to purchase liquor for any guest under the age of 18 years.

## **8. SUMMARY**

The House Rules are framed with you, the member, in mind so that you and your guests may peacefully enjoy the Club's facilities.

Any breach of these Rules may result in a fine, suspension or cancellation of membership, so please enjoy the facilities of the Club and allow other members to do likewise.
